KEY HIGHLIGHTS

Jessella continues to progressively erect the scaffolding to Crane Heights and establish a base of operations - this will facilitate the removal of the cladding system over the coming months.

- Scaffolding to Crane Heights remains on programme the next stage will see the progressive erection of scaffolding to Daneland Walk and to the Lee Valley Estate Office.
- Scaffolding to Merlin Heights is planned to commence from April - engineering checks are currently underway.
- Internal condition surveys have commenced at Crane
 Heights and will continue to be carried out over the coming
 weeks. Surveys will begin at Merlin Heights week
 commencing 27th February.
- The temporary traffic management application for Mill Mead Road is being arranged with LB Haringey.

MONTHLY PROGRAMME UPDATE

P1 - Crane Heights: Continuation of scaffold erection to Daneland Walk and scheduling of Internal Condition Surveys.

P2 - Merlin Heights: Scaffolding design & engineering underway with Internal Condition Surveys scheduled to commence imminently.

P3 - P5 - Egret, Kingfisher and Lapwing Heights: Programme to be advised.

Site Wide: The traffic management application for Mill Mead Road has been submitted to LB Haringey and pending approval. Ground conditions are being checked across site with test holes to the communal gardens and paved landscaping.
